

Licence agreement concerning inclusion of doctoral thesis in the Institutional Repository of the University of Leiden

By signing and submitting this licence, you (the author or copyright owner) grant the University of Leiden the non-exclusive right to make your doctoral thesis available worldwide in digital form.

- with due regard for Article 21 of the University of Leiden's doctoral regulations 2024

The doctoral candidate:

- permits the University of Leiden to make his/her doctoral thesis available worldwide in digital form. This permission is non-exclusive;
- permits the University of Leiden to convert his/her doctoral thesis into other file formats or unto other media to ensure continued availability in the future, without affecting the contents in any way;
- permits the University of Leiden to make and store one or more reserve copies of this doctoral thesis for purposes of preservation and to ensure against loss of the files;
- declares that this doctoral thesis is his/her own work;
- declares that the digital and printed versions have identical contents. All illustrations (photos, tables, etc.) incorporated in the printed version are also integrally included in the digital version;
- also declares that his/her doctoral thesis does not infringe on the intellectual property rights of others to the best of his/her knowledge;
- declares that, in case s/he transfers his/her intellectual property rights regarding this doctoral thesis to a third party, s/he will require them to accept this licence and honour this agreement;
- grants the licence in question indefinitely;
- relinquishes the right to terminate this licence through cancellation or annulment;
- declares that s/he, for any contribution based on work sponsored or subsidised by an institution or organisation other than the University of Leiden, s/he has fulfilled all obligations concerning publication imposed by this sponsor, institution or organisation;
- declares that s/he has the right to grant permission as specified in this licence, with the exceptions given below:
- 1. regarding the material contained in chapter(s)

he/she has no (or only partial) intellectual property rights and/or copyright. For this material s/he has obtained full permission from the rights holder to grant the University of Leiden this licence. It is clearly indicated in the text or contents of these chapters which material this concerns and what its source is;

2. The material contained in chapter(s)

If it is accepted by the publisher, s/he shall send a copy of the agreement reached with the publisher to the University of Leiden (University Libraries Leiden – MDA, Van Steenis Building, Einsteinweg 2, 2333 CC Leiden). If these agreements demand it and only to that extent, the embargo can be extended by a period of at most two years. If these agreements favour placing the material under embargo for a period exceeding two years, the Doctorate Board of the University of Leiden will set a reasonable duration of the embargo, taking into account the agreements made with the publisher and any additional information provided by the doctoral candidate.

3. The material contained in chapter(s)

has been accepted by a publisher for publication. The agreements made with the publisher (a copy of this agreement must be attached) require placing this material under embargo for [select from 6-24 months]

4. The material contained in chapter(s)

has already been published or accepted for publication by a publisher. The agreements reached with the publisher (a copy of this agreement must be attached) favour putting this material under embargo for a period exceeding 2 years. The Doctorate Board of the University of Leiden will set a reasonable duration of the embargo, taking into account the agreements made with the publisher and any additional information provided by the doctoral candidate.

The University of Leiden:

- declares it shall not transfer this licence to a third party;
- declares that it has received the digital copy of the doctoral thesis;
- will indemnify the doctoral candidate for damage claims from the publisher, if the publisher objects to the expiration of the embargo mentioned above.

As a contribution towards the cost of printing the thesis, the candidate will receive a compensation of € 500, to be paid by the University library after receiving two printed copies of the thesis, a digital copy of the thesis and the signed licence for non-exclusive publication of the thesis in digital form.
